

PRIVACY POLICY

Eos Rejuvenation believes that user privacy is integral to the success, growth and use of the Internet. This statement describes the practices that we will follow in respect to the privacy of site users. This statement may be reviewed and changed as new services and programs are introduced which require modifications to this statement. Eos Rejuvenation encourages you to re-read this Privacy Policy periodically.

Eos Rejuvenation does not collect personally identifiable information regarding the users of its Internet site – including e-mail addresses – without asking the user. In some instances, he may request that users voluntarily supply information, including e-mail address, street address, telephone number or other information, to allow him to personalize and enhance a users’ site visit or to provide the opportunity for follow up after the site visit. Whether users provide information is entirely voluntary.

You must be at least 18 years old to have our permission to use this site. Our policy is that we do not knowingly collect, use or disclose personally identifiable information about visitors under 18 years of age.

Use of information provided

If you voluntarily provide information, you consent to the collection and use of your personally identifiable information by Eos Rejuvenation. However, Eos Rejuvenation does not sell or rent personal information collected through this site to anyone.

Eos Rejuvenation may provide aggregate statistics about Web site visitors, such as volume, traffic patterns, referral sources and related site information to reputable third-party vendors, but these statistics will include no personally identifiable information about the users. We will disclose such information upon receipt of a court order, subpoena, or to cooperate with a law enforcement investigation. Eos Rejuvenation reserves the right to report to law enforcement agencies any activities that we in good faith believe to be unlawful.

If you have voluntarily provided personally identifiable information, Eos Rejuvenation may, from time to time, send mail or e-mail to you regarding products and services. If you do not want to receive such offers and mailings, you can easily indicate that by checking the appropriate box on the submission form.

Regarding cookies

Eos Rejuvenation may utilize a standard Internet technology called “cookies” to collect information about how the Eos Rejuvenation’s site is accessed and utilized. Cookies can allow a web site operator to determine that a user visited the site in the past and thus save and remember preferences that the user may have set while browsing the site. Cookies do not allow the Web site to retrieve any other data from your hard drive or obtain your e-mail address. While users maintain the ability to modify browser settings to either accept all cookies, notify you when a cookie is sent, or reject all cookies, it may not be possible to utilize certain services which require registration if the browser is set to reject cookies.
